INVITATION FOR INPUTS AND COMMENTS ON THE 2018/2019 DRAFT TARIFF STRUCTURE PROPOSAL

NOTICE IS HEREBY GIVEN IN TERMS OF SECTIONS 17, 21 and 95 OF THE LOCAL GOVERNMENT MUNICIPAL SYSTEMS ACT NO 32 OF 2000, AS AMENDED AND SECTIONS 17, 21, 22, 23 and 24 OF THE MUNICIPAL FINANCE MANAGEMENT ACT NO 56 OF 2003

This notice serves to inform the public and stakeholders that CHDM has reviewed the current Tariffs and is proposing an inflation linked increase to the tariff structure. The public and stakeholders are hereby invited to submit comments and inputs on the Draft Proposed tariffs for 2018/2019 financial year that will be approved by Council before the end of May 2018.

CHDM proposes a consumer price index (CPIX) based increase of 6% on all Water, Sanitation and Municipal Health Services Tariffs to be implemented for 2018 /2019 financial year as detailed below.

The Draft Tariff Structure for 2018/2019 will also be available on the CHDM Website as well on notice boards in all satellite offices of CHDM.
